**Business Checking** - There is a Minimum Average Daily Balance of \$1,000.00 to avoid a monthly charge of \$10.00 and to earn dividends.

**Payroll Checking** - There is a \$100.00 deposit required to open account. There is a \$50.00 a month fee.

**Non-Profit Checking** - There are no minimum balance requirements. No monthly fee.
